Through the referenced letter the Committee has been served the subject order passed by the Hon'ble Gujarat High Court. Vide the subject order, Union of India has been directed to grant the provisional permission to your college, which were earlier denied by the Union of India, and, which denial of the Union of India, had become a subject matter of challenge in a writ petition where the subject order is passed.

As such the subject order is an interim order against the Union of India, to grant provisional permission Upon due intimation of the grant of provisional permission, the committee shall permit admissions to your college on seats for which provisional permission may have been granted.

It is pertinent to note that though the subject order is served upon the Committee through the reference letter, a decision of the Union of India in compliance of the subject order is as yet not served upon the Committee. The directions in the subject order to the
